## President's Letter . . .

Dear Family Tree Friends,

We at Family Tree are celebrating but we are not relaxing. For the past 30 years, we have been providing shelter, counseling, case management and support to thousands of women and children and youth and families who were abused, homeless and/or in crisis.

We began as an agency that provided shelter to abused and neglected youth, youth for whom home was unsafe and parents abusive. Our beds provided safety and unconditional acceptance and support that young people deserve a chance to learn to care for themselves and for others. At Family Tree Gemini we continue to provide a residential treatment program for boys and girls, ages 11 up to 18, who need a safe place. We also seek out runaway and homeless youth on the streets and through the schools and provide them with shelter and/or information about how to get home or be safe. And yet children are living on the streets because they have run away from unsafe homes.

We soon added Family Tree Women In Crisis, a shelter for women and their children, who needed to escape the violence in their own homes. Our thirty-bed facility continues to provide everything needed by a family fleeing home, such as clothing, personal care items, food, and most importantly a confidential, safe place to stay.

Now we also provide to victims of domestic violence, rape and stalking support in legal matters, assistance in completing protection order paperwork and accompaniment to court. We have services targeted to child witnesses of family violence to help them understand what is happening to them and how they can keep themselves safe. We provide safe exchanges and supervised visitation for children for whom the court has outlined contact with the nonresidential parents at Family Tree Karlis Family Center. And yet deaths occur each year for victims of domestic violence.

Recognizing that affordable housing was often the greatest barrier to safety, we began a transitional housing program. Now we offer both transitional and permanent housing programs to nearly 150 families at a given time in scattered sites in the Denver metro area, including our 29 housing units owned and operated by Family Tree Housing and Family Services. We have also added to our continuum of services a 30-bed, 90-day transitional shelter program for homeless women and their children, Family Tree House of Hope. And yet families are the largest and fastest growing segment of the homeless population.

Emphasizing our belief that all children should be safe from abuse and neglect and receive what it takes to remain in safe homes, we have added several significant contracts with Adams County Department

of Social Services. And yet children continue to be abused by their parents.

And knowing that you the community wish to support the work that we do in many ways, we continue to operate what we think is one of the best thrift stores in the metro area, Treasure Trunk. We operate a comprehensive volunteer program with extensive training and a broad range of opportunities for individual and group volunteers.

You might think we could sit back after 30 years and say, "Haven't we done well?" As our supporters and volunteers, you might be tempted to say, "Haven't we done enough?" Our staff might say, "We are too busy now. Let's rest a while." And we all must say, "NO!" We will not rest. There is much more to do until every child is safe from abuse, every family has an affordable, safe home, and our community is proud to be measured by how we treat those most in need. Watch us. There is more to do and we are excited about doing it. Watch us and support us as we do the work you want us to do.

## Children's Services

Family Tree serves children and adolescents who have been abused or neglected and are not safe in their homes; youth who are homeless on the streets or have run away from home. We serve youth who are at risk of being removed from their homes due to behavioral problems. We assist families with unsubstantiated child abuse reports in an effort to stabilize those families, and we help families who are caring for family members, not their own children, when parents are unable to do so.

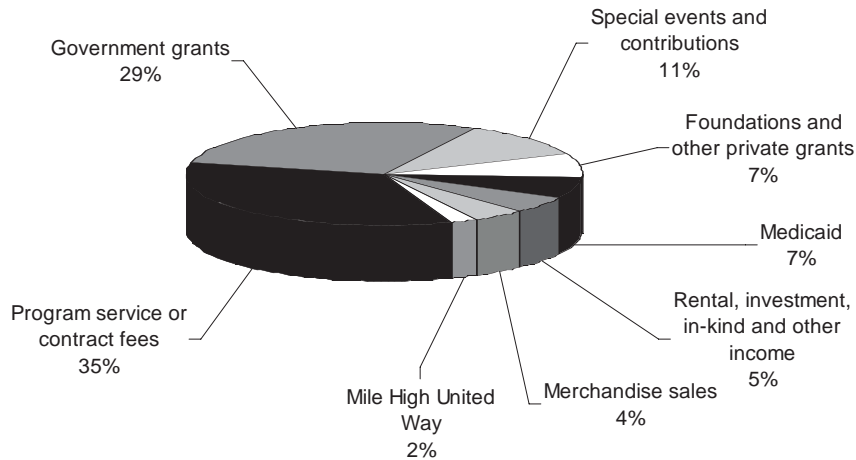

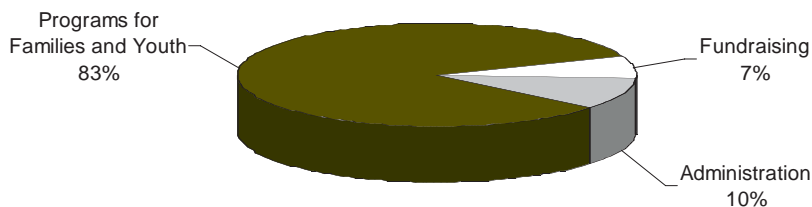
